## Job Summary

The main purpose of the position is to support the team as required of the FGGIII project. The fellow will partially be responsible for attaining the organizational emergency and priority as per requirements.

## Key responsibilities include (not limited to)

### Support to organize events, mobilize community and CSOs (Total Time: 50%)

- Support to the FGG team including partners and networks to organize events e.g meeting, workshop, training, seminar, dialogue, campaign etc.
- Support to mobilize community, grass-roots organization and CSOs including their campaign, lobby and advocacy initiatives.

### Develop relevant case stories and collect evidence (Total Time: 50%)

- Prepare case stories and collect evidence on energy transition, environment, climate, land and human rights as required by the team, community and CSOs.
- Support to archive relevant document and information. Support to prepare situation report and event report.
