The Fellows will work at the intersection of community engagement, research, and policy advocacy, contributing to strengthening constituency-level renewable energy planning and influencing national discourse on Just Energy Transition and Climate Justice. The role is designed to integrate field-level realities with evidence-based advocacy, supporting both grassroots engagement and analytical work.

Key responsibilities include (not limited to)

Mobilization & Stakeholder Engagement

- Facilitate constituency-level dialogues with Members of Parliament (MPs), local government, CSOs, private sector, and communities
- Support stakeholder mapping and mobilization through JETnet-BD and partner networks
- Conduct community consultations to identify local energy needs and opportunities

- Support planning and implementation of capacity-building workshops for MPs and stakeholders.
